## Recreational Vehicle Rental Agreement

I, \_\_\_\_\_, do hereby agree to rent the 2104 Lance 1985 Travel Trailer 19', VIN 56YTT1929EL314394, from Ashley or Josh Beene under the following terms and conditions.

1. The rental shall be from **MM/DD/YYYY** to **MM/DD/YYYY**.
2. The sum of the rental shall be **\$total including delivery, insurance and cleaning** USD.
3. The nightly sum of **\$amount**, delivery of **\$amount**, cleaning of \$45, RVshare service fee of **\$amount** and insurance of **\$amount** are included in the rental price. The security/damage deposit for this rental is \$500.
4. The camper shall be delivered to **campground and address** at **time** on **MM/DD/YYYY** and not moved from that location.
5. A maximum of four people may reside in the trailer.
6. I will not have a pet inside the trailer. If there is evidence of a pet, I will be subject to the additional cleaning fee of \$200, plus potential forfeiture of my security deposit, at the owners' discretion.
7. If I have stated that I will not smoke inside the trailer. If there is evidence of smoking, I will be subject to the additional cleaning fee of \$500, plus potential forfeiture of my security deposit, at the owners' discretion. "Smoking" includes smoking of tobacco products, salvia, narcotics, marijuana and vaping.



8. For delivery renters there are no dumping fees, unless the camper is relocated and tanks are not emptied. Delivery renters are not subject to camper refueling fees.

9. The generator is included, without deposit, for renters renting for three or more nights. For these renters, two hours per day is included; additional usage is \$10 per hour or partial hour. For renters with less than three nights, the deposit is \$200 and all generator usage is \$10 per hour or partial hour. Beginning hour meter reading is noted on delivery form. A cargo carrier for the trailer's bumper and lock is provided. Renters are not required to use the generator; however, they are responsible to keep the trailer's batteries from dropping below 11.7 volts. A volt meter is included with the trailer. Failure to return the generator is a fee of \$958. The generator is not available for renters with an electric hook-up.

10. Only RV-specific fast-dissolving toilet paper may be used. I will be subject to additional clearing/dumping fee of \$100 and any repair costs.

11. No firewood inside the camper due to possible termite infestation and damage to the interior.

12. No bicycles in the trailer.

13. Lost keys fee is \$40.

14. RVshare's rental agreement must be electronically signed to initiate rental. Owners' rental agreement must be signed and delivered to the owners via hard or electronic copy to initiate rental. The two agreements supplement one another.

15. Insured through RVshare.

16. I agree to have the trailer ready for return by the agreed upon time, **time** on the return date of **MM/DD/YYYY**. If the renter would like to stay in the campsite until the check-out time, the trailer must be vacated ten minutes prior to campground check-out time so the campsite is vacated by at that time. Fees charged by the campground for late check-out are the responsibility of the renter. The owners will disconnect the hook-ups, lift the stabilizing jacks & remove the wheel chocks and dump the trailer tanks.

17. I have read and agree to all rental rates.
