Owner Rental Agreement for 2021 Montana 3761FL RV and Optional 2018 GMC Denali 2500HD Truck Rental

This **Owner Rental Agreement** ("Agreement") is entered into by and between the Owner ("Owner") and the Renter ("Renter") for the rental of the 2021 Montana 3761FL RV ("RV") and the optional 2018 GMC Denali 2500HD Truck ("Truck"). By signing this Agreement, the Renter agrees to the terms and conditions outlined below for the rental of both vehicles.

1. RV Rental Terms

The rental of the RV will follow the standard terms and conditions as agreed upon through RVshare's platform, including:

- Renter must maintain valid RV Share or comparable insurance for the RV.
- The RV must be returned in the same condition as at the start of the rental.
- Additional mileage, cleaning, or damages will incur extra fees as outlined in the RV listing.

2. Optional Truck Rental Terms

If the Renter opts to rent the 2018 GMC Denali 2500HD Truck, the following additional conditions apply:

a. Insurance Coverage:

 The Renter must carry private insurance with full coverage for towing the RV, including liability and collision coverage for both the truck and the RV.

b. Mileage Policy:

• The Truck rental includes **250 complimentary miles** for the entire trip. Any miles beyond this limit will be charged at **\$2 per mile**, based on the recorded mileage at the end of the rental period.

c. Fuel Requirements:

• The Truck must be returned with a **full tank of diesel**. Any costs for refueling will be deducted from the security deposit if the truck is returned with less than a full tank.

d. Towing Capacity:

• The Truck must not exceed its **recommended towing capacity**, which includes hauling the Owner's RV or any other agreed-upon items such as boats, travel trailers, or flatbeds. Overloading the vehicle may result in damages, which the Renter will be responsible for covering.

e. Responsibility for Damage:

 Any damage to the Truck during the rental period, whether caused by improper towing, overloading, or negligence, will be the Renter's financial responsibility.

f. Rental Terms and Return Condition:

 The Truck must be returned in the same condition it was rented, with all systems and components functioning. Any cleaning or repairs required due to misuse will be charged to the Renter.

 The Owner is not liable for any accidents, injuries, or damages caused by the misuse or improper operation of the Truck or RV. The Renter assumes full responsibility for ensuring all equipment is operated in accordance with safety and operational guidelines.

RVshare is not a party to this Owner Rental Agreement and is not responsible for the
terms or enforceability of this Agreement. The Renter acknowledges that this Agreement
is strictly between the Owner and the Renter and that RVshare has no liability or
involvement in any disputes that may arise under this Agreement.
