

Towing a Trailer Statement of Responsibility and Liability Waiver

I understand that towing a trailer adds certain considerations to the RV rental and that **it is my sole responsibility as a renter to ensure that those considerations are understood, and that proper steps and equipment have been put in place to address these risks and comply with any and all relevant state, local, and federal requirements.** I agree that I will be **financially liable for all damages that occur to the trailer both internally and externally.** I also understand that insurance may or may not provide coverage for such things and that it is my sole responsibility to arrange for insurance where necessary. Failure to obtain insurance or denial of a claim is not grounds for omission of responsibility. **I understand and agree that I am responsible for paying any deductibles, fees, expenses, or cost of repairs associated with my use of the subject property.**

I, _____ (Renter) will not hold Cor13 LLC (Owner(s)), or any person or entity associated with the Property Manager or Owner including contractors, volunteers, or family members, responsible for any loss, damage to any person, or damage to the trailer whether it is the result of accident, negligence, or any other cause.

The considerations below may mitigate the risk present with towing a trailer, but do not constitute a complete list of all considerations. By initialling next to each of these items I agree that I have read, acknowledged, and accepted such responsibilities and that it is my responsibility to ensure safe and legal transport of the RV, passengers, and tow vehicle.

1. _____ It is my responsibility to comply with the laws of the state of Oklahoma, or any other state or regulatory authority wherein I am towing the trailer. This includes, but is not limited to, regulations related to Equipment such as trailer brakes, lights, towing weight limitations, footage limitations, towing chains, or any other safety requirements, as well as licensing, fees, and permits.
2. _____ I understand that trailers, as well as tow vehicles, have weight limitations and failure to comply with such limitations can result in fees, fines, penalties, and/or result in damage to the trailer, towing vehicle, and other parties. I agree to comply with all regulations related so such laws. I further acknowledge that I have been provided the information necessary to evaluate such limitations, and that it is my responsibility to comply with such.
3. _____ A trailer brake controller may or may not be necessary, but is always recommended, when trailer brakes are present. A trailer brake controller may be provided to match the travel trailer if necessary, but it is always my sole responsibility to ensure its proper functioning and performance. It is recommended that you test any trailer brake controller as stated in the trailer brake controller manual, and at a minimum at the onset of any journey. I acknowledge that any failure of such device, whether loaned to me as a courtesy, or provided on my own, is my sole responsibility.
4. _____ I will use the electrical connector on the tow vehicle to attach the trailer's electrical connector for taillights, turn signals and brake lights, and it is my responsibility to ensure these items are properly functioning at all times.
5. _____ I will use the safety chains provided on the travel trailer to secure the trailer to the tow vehicle, crossing the chains under the tongue and ensuring they are properly affixed to the two vehicle in an approved manner. I further confirm that the tow vehicle hitch and safety apparatus is in proper working order and is up to the task and proper rating for towing the trailer I am renting.
6. _____ I will connect the breakaway cable between the tow vehicle and the trailer.
7. _____ I am responsible for supplying my own hitch and ball and certify that they are correctly sized. If needed, the owner may provide a hitch and ball for a proper receiver, but it is up to the borrower to assume inspection and approve use of the item.
8. _____ I certify that the weight limit for the tow vehicle, the hitch, and all other items is adequate for the travel trailer rented.
9. _____ I certify that I understand how to avoid trailer sway. I agree that if I cannot drive at a speed and under load conditions to avoid trailer sway, I will slow down and/or redistribute loads in the tow vehicle and trailer to prevent trailer sway, damage, or potential accidents.
10. _____ I certify that the tow vehicle tires, brakes, and other necessary mechanical components are in good condition, with sufficient material, and within proper specifications such. This includes consideration of air pressure, tread life, pad life, electronics, etc.
11. _____ I agree that I am responsible for hitching the trailer to the hitch ball properly, as well as any other connections, safely.
12. _____ I certify that I have pulled trailers before and that I understand how to properly turn and back up with the trailer.
13. _____ I certify that the tow vehicle is in proper working condition, and acknowledge the lessor is not responsible for any damage that may occur to my vehicle as a result of towing the item in which I am renting listed here.
14. _____ I acknowledge it is my sole responsibility for damage to any such device, or equipment, provided to me and accept responsibility for the failure of operation of any such item. This includes improper use, as well as malfunction and that I will be responsible for the cost of repairs or replacement to such items along with any subsequent financial obligations which may arise.
