## Prohibited Used of Travel Trailer:

\_\_\_\_ PROHIBITED USES OF THE TRAVEL TRAILER: The travel trailer will not be used or operated by anyone:

1. Who is under 25 years of age.
2. Who is not listed as an additional driver on the rental agreement.
3. To carry persons or property for hire.
4. In any race, test, or similar type of contest or activity.
5. In a careless or negligent manner.
6. Under the influence of alcohol or narcotics.
7. Outside the continental United States UNLESS WRITTEN PERMISSION HAS BEEN GIVEN BY RENTAL OPERATOR PRIOR TO RELEASING THE TRAVEL TRAILER.
8. For any illegal purpose or in the commission of a crime.
9. If the travel trailer is obtained from the Rental Operator by fraud or misrepresentation.
10. Other than on paved roads or graded private roads or driveway.
11. Who loads the travel trailer behind its rated capacity.
12. Who allows more passengers than the travel trailer is designed for.

## Responsibility For Care:

\_\_\_\_ The Renter is responsible for the proper care, handling, and operation of the travel trailer during the rental period. The Renter agrees to keep the travel trailer clean and free of any damage.

## Responsibility To Report All Accidents, Incidents of Theft and Vandalism:

\_\_\_\_ Renters must report all accidents or incidents of theft and vandalism to the police as soon as they are discovered and must report all accidents, incidents of thefts and vandalism to us within 24 hours of occurrence..

### Awning Acknowledgement:

\_\_\_\_ I acknowledge that I understand about the use of the electric awning. I acknowledge that I understand that I am being given a camper with a fully functional awning. I acknowledge that if there is any damage to the awning at the beginning of the rental period listed on this agreement, I will make note of it on the condition of rental at rental within this agreement. I acknowledge that when the camper is returned and the awning is damaged whether it be by the operator, wind, rain or any other factor that I am 100% responsible for damages.

Over 50% of all damage claims pertain to RV awnings. Awnings can be easily damaged by high winds, rain, suspending items (lights, towels, etc.) from the arms or rails. We do not prohibit the use of awning as it is a valuable part of the camping experience. However, use of the awning is the sole responsibility of the renter. The average cost to replace an awning is between \$800 and \$3000 (This is to be paid immediately following the damage to the travel traveler). It is recommended that the awning be brought in (closed) when not at the camper, at night and during high winds/rain.

### Liability & Warranties:

\_\_\_\_ The Renter acknowledges and agrees that the Owner shall not be liable for any injuries, damages, or losses arising from the use of the travel trailer, including but not limited to accidents, misuse, or negligence on the part of the Renter or any third party. Renter acknowledges that OWNER MAKES NO EXPRESS OR IMPLIED WARRANTY OF ANY KIND WHATSOEVER WITH RESPECT TO THE TRAVEL TRAILER, INCLUDING, BUT NOT LIMITED TO: THE MERCHANTABILITY OF THE TRAVEL TRAILER OR ITS FITNESS FOR ANY PARTICULAR PURPOSE.

### Insurance:

### No Smoking Acknowledgement
