- Gas will be full at pick up and should be returned full to avoid a \$150 refueling fee
- Waste tanks (Black and Gray) will be empty at pick up and should be returned empty to avoid a \$75 fee

Owner Responsibilities:

- The Owner agrees to provide a clean and well-maintained RV, with all systems in good working order.
- The Owner agrees to provide instruction on the operation of the RV and its amenities at the time of pickup.
- The Owner agrees to provide emergency contact information for assistance during the rental period.

Additional Terms and Conditions:

- Smoking is strictly prohibited inside the RV.
- Pets are not allowed inside the RV without prior approval from the Owner.
- Any violations of the terms and conditions of this Agreement may result in termination of the rental agreement and forfeiture of the security deposit.
