This agreement is in <u>addition</u> to rental contract by RVShare. All rules/policies must be followed, or penalties and loss of deposit and/or additional charges will be charged to the renter.

Up to two pets (dogs/cats) are welcome provided they are each under 50 pounds. A \$50 per pet cleaning fee is required. You must advise us of breed and size when making reservation as some breeds are not allowed.

NO Smoking or drugs in the coach. You will forfeit your entire deposit if you choose to do so. If you have a campfire near the coach, please keep doors and windows closed to limit smoke drift into coach.

NO illegal activity of any kind.

Only verified drivers are allowed and must be over 25. Preference is someone that has driven a rig of this size before.

No outdoor concerts/festivals. Deposit will be forfeited should you not abide by this policy. Additional charges could apply.

The coach must be brought back full of fuel, or you will be charged \$50 plus \$5.25 per gal for fuel.

Propane is to be returned full. If not, estimated usage will be calculated and charged based on current pricing.

Both black and gray tanks must be returned empty. If not, you will be charged \$75

Cleaning and sanitation fee: \$75

You are responsible for any tolls, tickets, tows, impounds, etc. Even if the notice arrives after the trip.

Tire damage is responsibility of the renter. If the renter believes the damage is due to owner negligence, the tire must be returned for professional evaluation. Reimbursement is based on the result.

If there is a mechanical failure or problem requiring roadside assistance, renter will call the assistance number provided by the insurer AND notify the owner immediately. Renter shall not attempt to make repairs. Out of pocket expense for repairs is required and which are not covered by insurance or roadside assistance will be reimbursed by owner upon return of rig provided the owner is made aware prior to the repairs and receipts are provided. If the cause of the issues are due to renter causes, the renter will be charged.

Renter is responsible for checking/maintaining engine oil level, tire pressure and coolant levels at each refueling stop. Cost due to renter negligence will be the renter's responsibility.

Owner will provide information on the operation of the coach and its systems at time of pickup and will provide manuals in advance. It is the renter's responsibility to understand and follow these instructions. Failure to use proper handling of any of the systems, features or appliances in the coach may result in damage and renter will be liable for cost to repair.

NO climbing on the roof.

Pickups and returns are to be during daylight hours only. Returns after dark will be charged an additional rental day. Check in will not be done until the following day.

No northbound rentals December through March.

<u>GPS</u>

This coach is equipped with a GPS tracking system that reports location and speed to the owner. **Speed limit for this coach is 65MPH.** Any sustained (30 minutes) speed over this policy will be charged \$25 for each occurrence. This is intended to assure the safety of the renter and passengers. It is also recommended that the maximum driving time per day is 8 hours. Removing the GPS unit will result in full forfeiture of your deposit.

Renter must provide owner with planned route and addresses of overnight stays.

Owner provides renter with a Garmin GPS unit specifically designed for RV's. This will give you a route that considers the specifications of the coach to avoid any routes that would create driving problems.
