4. Security Deposit

A refundable security deposit is held for potential damages, late returns, excess cleaning, smoking, or dumping violations.

5. Cancellations & Refunds

Subject to RVshare's cancellation policy as listed in the rental listing.

6. Use Restrictions

The Renter agrees:

- No smoking in the RV (\$500 fine)

- No pets
- No climbing on the roof
- No towing
- No attendance at music festivals, unless approved
- To obey all traffic laws and campground rules
- To only allow qualified, licensed drivers (25+ unless otherwise noted)

7. Insurance and Roadside Assistance

The Renter must purchase insurance coverage through RVshare or provide proof of approved third-party RV rental insurance. Roadside assistance is highly recommended.

8. Maintenance and Repairs

Renter agrees to notify the Owner immediately of any issues or damages. Repairs over \$50 require Owner's prior written approval for reimbursement.

9. Cleaning and Waste Disposal

RV must be returned clean inside and out. All gray and black tanks must be emptied. Dumping fees apply if not completed (\$100 minimum).

10. Indemnification

Renter agrees to indemnify and hold Owner harmless from any and all claims, liabilities, damages, or losses arising from Renter's use of the RV.

11. Inspection

A walk-through inspection will be conducted before and after the rental. Both parties shall document the RV's condition with photos.

12. Default

Any breach of this Agreement by the Renter may result in termination of the rental without refund and forfeiture of the security deposit.

13. Governing Law

This Agreement shall be governed by the laws of the State of [Your State].
