| <b>2. PICKING UP YOUR RENTAL:</b> Renter will need at least 45 minutes to check-out on the first day of the reservation. This allows a full orientation of all aspects of the unit you have selected. Pick-Up is based on scheduling and availability. Pick-Up times are scheduled on a first come first serve basis. We can not guarantee that your preferred time will be available. Earlier pickup times may be accommodated as a courtesy only. All pickups are scheduled and by appointment only. If appointment time is missed, the pick-up time can be reschedule for the next available opening.  |  |  |
| <b>3. RETURNING YOUR RENTAL:</b> Rentals are due back by 2:00 p.m. on your scheduled day back. Late returns, without prior approval will result in additional night charge. Renters will need time to check the Rental back in, so please allow 30 minutes or longer. While we do a complete walk-through of the Rental upon return, we have a 2-day "post rental" detailed inspection that is completed to ensure there are no issues with the Rental following your time period. After we have completely checked in the Rental, we will mail (within 14 business days) your FULL deposit refund (less any adjustments for damages, if applicable). Late returns are accommodated as a courtesy only. Our goal is to make sure the next renter has a properly prepared and cleaned Rental. Lost rental income due to late returns will be the renters responsibility. If Renter chooses to allow Joshua Branch to clean and empty the black and gray holding tanks, a \$75 fee will be subtracted from the deposit. Due to the use of propane in all units for heat, stove and hot water needs, a \$10 flat fee will be added to unit rental price. |  |  |
| <b>4. PAYMENT POLICY:</b> A reservation/damage deposit of \$1000 is required to hold your reservation during a non-holiday week. An inspection is done after each check-out for any damage done to real or personal property. The renter(s) shall be liable and solely responsible for any property damage, accident, injury to any person or loss sustained by any person or arising out of or in any way related to renter(s) use of the premises or the items of personal property provided by Joshua Branch hereby agrees to indemnify and hold Joshua Branch harmless from any and all claims, including those of third parties, arising out of or in any way related to renter(s) use of premises or items provided therein. Renter(s) assumes the risk of injury or other losses relating to any recreational activities and will hold Joshua Branch harmless with respect thereto. Renter(s) agrees to indemnify for any damages to the dwelling, grounds, furnishings, and household items. In the event that damage result from a renter(s) occupancy, Joshua Branch is authorized to utilize the credit card on file or the cash security deposit to cover said damages or additional cleaning costs, including the charging or billing of any additional amounts that exceed the deposit held. Advanced RV Rental is not responsible for articles left on premises. There will be a \$10.00 charge in addition to shipping charges for handling the return of any articles found by housekeeping. Lost & Found will be held for 30 Days. After such time all items will be donated to charity. |
| <b>7. CLEANING</b> : Each property will be inspected, sanitized and cleaned after your departure. We ask that the unit be returned in the same general condition that you received it. If a significant cleaning is required, appropriate charges will be deducted from your deposit. Please be sure to empty the holding tanks before the unit is brought back. If Renter would rather not empty, Joshua Branch will empty for the Renter at an additional \$75 charge.   |
| <b>8. NO PETS OR SMOKING ARE ALLOWED:</b> Since many people have allergies and it is difficult to remove the odors and allergens associated with both pets and smoke, we must STRICTLY ENFORCE this policy. If evidence of pets on site or evidence of smoking inside the Renal is found, Joshua Branch reserves the right to charge \$250.00 to treat the property for fleas and/or allergens. In addition, any damage caused by pets or smoking materials will be charged to renters damage deposit or credit card on file.  |
| <b>9. WHAT WE SUPPLY</b> : Included in your reservation, Joshua Branch supplies the Rental with clean sheets and all your kitchen/bathroom item needs. EACH ITEM TAKEN FROM THE UNIT WILL RESULT IN A CHARGE OF \$20 EACH TO YOUR CREDIT CARD. In any action concerning the rights, duties or liabilities of the parties to this agreement, their principals, agents, successors or assignees the prevailing party shall be entitled to recover reasonable attorney fees and costs.
