## 5. Security Deposit:

The security deposit will be refunded within **7** days of the end of the rental period, provided no damage or excessive cleaning is required. Deductions will be made for any damage, missing items, or if the RV is not returned in the same condition as when it was rented.

# 6. No Smoking:

Smoking is strictly prohibited inside the RV. Violation of this rule will result in a forfeiture of the security deposit and an additional cleaning fee of \$200.

#### 7. Insurance:

The Renter must provide proof of insurance coverage for the rental period. The insurance must include comprehensive and collision coverage.

#### 8. Maintenance and Breakdown:

In the event of a mechanical breakdown, the Renter must notify the Owner immediately and follow the Owner's instructions.

#### 9. Use of RV:

The Renter agrees to use the RV in a careful and lawful manner, and will not use it for any illegal activities or allow it to be towed by anyone not authorized under this agreement.

## 10. Cleaning Fee:

A cleaning fee of **\$100** will be charged if the RV is not returned in a clean condition.

#### 11. Pets:

Pets are allowed for an additional fee of \$20.

## 12. Sewage Disposal

A dump fee of \$75 will be added for all rentals that do not have full hookup or campground without dump sites.

### 13. Indemnification:

The Renter agrees to indemnify and hold the Owner harmless from any claims, actions, suits, proceedings, costs, expenses, damages, and liabilities, including attorney's fees arising out of or related to the Renter's use of the RV.

### 14. Termination:

The Owner reserves the right to terminate this agreement and retake possession of the RV at any time if the Renter breaches any of the terms and conditions of this agreement.

## 15. Governing Law:

This agreement shall be governed by and construed in accordance with the laws of the State of Michigan.

## 16. Entire Agreement:

This agreement constitutes the entire agreement between the parties and no other representations or statements, whether oral or written, will be binding upon the parties.
