Definitions

- "Contract" means all terms and conditions found in this form, and addenda and any additional materials we provide at the time of Rental.
- "You" or "your" means the person identified as the renter on this form, any person signing the Contract, any Authorized Driver and any person or organization to whom charges are billed by us at its or the renter's direction. All persons referred to as "you" or "your" are jointly and separately bound by this Contract.
- "We," "our," "us," "I," or "my" means the private owner(s) and property manager(s) renting the Vehicle to you.
- "Web Platform" means the rental search engine that may have been used by the private owner(s) and manager(s) as an intermediary.
- "Authorized Driver" means you and any additional driver approved and listed by us on this Contract.
- "Vehicle" means the recreational vehicle identified in this Contract.
- "Loss of Use" means the loss of our right to use the vehicle for any reason because of damage to it or loss of it during rental. Loss of use is calculated by multiplying the number of days from the date of damage to the vehicle until it is repaired or replaced times the nightly rental rate.

Important Disclosures

- By signing this Contract, you understand and agree that you assume all liability, whether collision, damage, or liability for the entire duration of the Rental. You agree to indemnify the Owner(s) and Property Manager(s) of the RV in any suit brought against them.
- You are covered by a web platform-supplied **insurance** policy with a minimum \$ 1,500.00 deductible, or by a Certificate of Insurance from your insurance company, or a commercial insurance policy from the owner. Chips in the windshield or other glass are not covered by the policy unless indicated by the insurance coverage selected. Interior damage is not covered by the policy unless an interior damage protection plan is purchased.
- You are **financially** responsible for **all** damage (both **exterior and interior**) to, or loss or theft of, the Vehicle, which includes the cost of repair or the actual cash value of the Vehicle if it is not repairable or if we elect not to repair it, **loss of use**, diminished value of Vehicle caused by damage to it or repair of it, missing equipment, connected with any damage claim whether or not you were at fault. The insurance coverage or security deposit **may** cover some or all of the damages. You will usually pay only the insurance deductible.
- You must report all **accidents** involving the vehicle to us and the police within 24 hours of occurrence.
- By signing this Contract, you understand and agree that there may be **optional products** that you may or may not opt to add on to your rental. You also understand and agree that there are conditional fees that may or may not be charged to you after the rental has been completed based on usage and damages.
- **Return instructions** are included as an addendum (1),

Terms and Conditions

1. You, _____, do hereby agree to rent the _____

2. The rental shall be from _____ to _____ (nights).
3. The sum of the rental shall be \$ _____ USD, plus \$.65 per mile over **100** miles per _____
(total free miles).
4. You understand that the sum of the rental includes a generator charge of \$ 0 per night for **3** hours or less, plus \$ 4.00 per hour for each hour over **3** (total free hours is _____)
5. You agree to pay a gasoline/diesel fee of **double the current cost per gallon** and a Propane fee of **\$ 15.00 per quarter tank**, to refill the propane or gasoline/diesel tank if it is returned less than full.
6. Additional charges include a wastewater dumping charge of **\$150.00** if applicable, and a delivery fee of **\$6.00** per mile travel mile plus **\$ 65.00** per travel hour plus actual fuel cost. You agree to pay these charges if necessary.
7. You understand that the sum of the rental includes a **cleaning fee** of **\$0** if returned clean or **\$ 75.00 per hour** if not returned clean and in the condition it was received inside and outside including undercarriage. (Burning Man and EDC see the statement of responsibility).
8. **Tires** are the renter's responsibility unless covered by insurance. The cost to replace a tire will be determined based on the current cost to replace the tire with a new tire of equal or comparable tire value. In addition to any damages caused by tire blowouts, and not limited to wheel alignments, bodywork, and trips to and from repair shops as noted in the departure form.
9. You understand that a **cleaning fee** is not the same as a **prep and sanitation fee** which is not the same as a **wastewater dumping fee**.
10. Broken, cracked, or chipped **windshields** are the renter's responsibility. The renter is responsible for the cost to replace the windshield unless covered by insurance, including trips to and from the repair shop as noted on the departure form.

11. **Scratches** on the RV caused by tree branches or bushes will be billed for buffing.
12. You agree to pay a **late return** fee of **\$ 85.00 per hour late fee up to double the nightly rate** if you do not return the vehicle as originally agreed.
13. You agree to pay a **late pick-up** fee of \$ 85.00 per hour late fee up to double the nightly rate if you do not pick up the RV at your scheduled pick-up time.
14. **Labor for repairs** not including parts not covered by insurance will be billed at a **\$ 85.00** per-hour fee. Repairs requiring trips to the repair facility will have a minimum transport fee of **\$150.00**. An administrative fee minimum of **\$100** will apply for each insurance claim filled: \$0-\$250 damage=\$100 fee \$251-\$500 damage=\$150 fee; \$501-\$750 damage=\$200 fee; \$751-\$1500 damage=\$300 fee; \$1501-\$2500 damage=\$400 fee; \$2501+ damage=\$500 fee.
15. **Pets are not permitted in the vehicle.** If there is evidence of a pet, you will be subject to an additional deep cleaning charge of a minimum of **\$350.00** plus potential forfeiture of your entire security deposit at the manager's/owner's discretion.
16. **Smoking/vaping is not permitted in the vehicle.** If there is evidence of smoking, vaping or other strong odors, you will be subject to the additional cleaning fee of a minimum of **\$350.00** plus potential forfeiture of your entire security deposit, at the manager's/owner's discretion.
17. The refundable **security deposit** for this rental is \$ **1,500.00** . The mandatory Preparation and Sanitation fee is \$ **199.00** .
18. **Burning Man Festival Cleaning Fee \$ 1,300.00.** If the RV is not returned in the condition it was given a Burning Man Cleaning Fee will apply. The renter is responsible for minimizing as much playa dust as possible from entering the RV by properly sealing and covering floors with painter's tape and ram board.
19. **Burning Man Festival Fee \$500.00:** Mandatory fee, that covers replacing air filters, generator maintenance, blowing out of engine parts, and air conditioner.
20. **No refund** will be given if you prepay for a service but do not use it.
21. You agree to **pick up** the vehicle at the specified location at the pre-arranged time. A late pickup fee of **\$85** per hour will be charged for each hour that the vehicle is picked up late. This fee may be waived at the Owner(s)' or Property Manager(s)' sole discretion if there are extenuating circumstances.
22. You agree to return the RV by the agreed-upon time, but no later than **2:00 PM Pacific Standard Time**, on the return date. **Unless arrangements have been made for a late return, a \$85 per hour late fee will be charged for each hour that the vehicle is returned later than the pre-arranged time.** This fee may be waived at the Owner(s)' or Property Manager(s)' sole discretion if there are extenuating circumstances.
23. **We have 48 hours from the time you return the RV to inspect it for damage not noticed at check-in. You have _____ hours from the time we submit the final check-in forms to dispute any damages or other charges.**
24. You release the Property Manager(s) and (Owner(s) from all claims for loss of, or damage to, your personal property or that of any other person, which is left or carried in the vehicle.
25. You agree to pay us on demand for all charges due us under this Contract, including but not limited to: (a) time for the period during which you take the Vehicle; (b) charges for additional drivers; (c) charges for the optional services; (d) applicable taxes if any; (e) all traffic, toll or parking violations, fines, penalties, citations, forfeitures, court costs, towing charges and other expenses involving the Vehicle assessed against us or the Vehicle; if you fail to pay a traffic or toll charge to the charging authority, you will pay us all fees owed to the charging authority including a **\$25.00** administrative fee for processing.; (f) **\$1,500** abandonment fee plus **\$6.00/mile** for every mile between the renting location and the place where the Vehicle is returned, repossessed or abandoned, plus any additional recovery expenses we incur including fuel and hourly rate of **\$65.00** per hour travel time (g) all costs, including pre-and post-judgment attorney fees, legal fees and court costs we incur collecting payment from you or otherwise enforcing our rights under this Contract; (g) a "loss of use" fee if you return the vehicle with damage that renders it unusable or un-rentable in the amount the daily

- rate every 8 hours for each day that it is unusable or unrentable (**this only applies to off platform rentals**); (h) **we will not refund any of the time or mileage charges if you return the vehicle earlier than the date or time due in**, (i) there is a **\$49.00** per day safety assessment for each day that you exceed **75** MPH as recorded by the GPS tracker.
26. You have truthfully disclosed the identity and proper age of all drivers.
 27. You acknowledge that there might be a **GPS tracker** installed in the RV, tampering or removing the tracker can lead to forfeiture of the deposit.
 28. You agree to **return the vehicle in the same condition in which it is received**. This includes odor-free and clean in the interior and exterior of the RV, including the undercarriage. (see addendum 1, Burning Man and EDC Statement of Responsibility.)
 29. You have read and agreed to all rental rates.
 30. You agree that **towing** requires prior approval.
 31. You are responsible for checking and maintaining all fluid levels during the rental period. **This includes checking the generator oil weekly if you use the generator.**
 32. Unless authorization is obtained from the manager(s) or owner(s), no repairs, replacement of parts or service shall be completed during the Rental period.
 33. The manager(s)/owner(s) are **not** responsible for the loss of vacation, personal or business time, or any incidental expenses incurred by the renter, resulting from breakdown or any other delay problems. The manager(s)/owner(s) shall be responsible for completing any necessary repairs and returning the vehicle to Rental condition as promptly as possible.
 34. You agree not to take the vehicle outside of the continental United States or Canada.
 35. You are responsible for reporting all accidents, incidents of vandalism, or theft to the police and the manager(s)/owner(s) upon discovery.
 36. You agree that all driver information has been reported accurately and that no unauthorized drivers shall operate the vehicle. All reported drivers must have a valid driver's license.
 37. You agree that all insurance information (if applicable) provided is true and valid.
 38. You agree that Vehicles shall **not be driven off-road on unpaved surfaces or on very rough roads of any type**.
 39. We may use your security deposit to pay any amounts owed to us under this Contract, which shall include replacement of fuel or LP gas, wastewater dumping, time and mileage, loss or damage to the vehicle, administrative or legal fees, fines, penalties, forfeitures, court costs, towing and storage charges and other assessed charges unless the expenses are our fault, all costs associated with locating and recovering the vehicle if you fail to return the vehicle as required by the terms of the Rental Contract. If the amount of your security deposit is insufficient to satisfy all amounts due, then you agree to pay all charges in excess.
 40. This is a contract for the Rental of the Vehicle. We may repossess the Vehicle at your expense without notice to you if the Vehicle is abandoned or used in violation of law or this Contract. You agree to indemnify us, defend us, and hold us harmless from all claims, liability, costs, and attorney fees we incur resulting from or arising out of, this Rental and your use of the Vehicle.
 41. We make no warranties, express, implied, or apparent, regarding the Vehicle, no warranty of merchantability, and no warranty that the Vehicle is fit for a particular purpose.
 42. You must return the Vehicle to the place of pickup or other location that we specify, on the date and time specified in this Contract, and in the same condition that you received it.
 43. If the vehicle is returned after the specified time, you remain responsible for the safety of, and any damage to, the Vehicle until we inspect it.
 44. The following acts or uses of the Vehicle are prohibited and **may result in forfeiture of the entire security deposit**: (a) driving the Vehicle: (i) by anyone who is not an Authorized Driver, or by anyone whose driving license is suspended in any jurisdiction; (ii) by anyone under the influence of drugs or alcohol; (iii) by anyone who obtained the Vehicle or extended the Rental period by giving us false, fraudulent, or misleading information; (iv) in furtherance of any illegal purpose or under any circumstance that would constitute a violation of law other than a minor traffic citation; (v) to carry persons or property for hire; (vi) in any race, speed test or contest; (vii) to carry dangerous or hazardous items or illegal material; (viii) outside the United

States and Canada; (ix) when loaded beyond its capacity, as determined by the manufacturer of the Vehicle; (x) when driven through or under an underpass or other structure without sufficient overhead or side clearance; (xi) when it is reasonable to expect you to know that further operation would damage the Vehicle; (xii) in a manner that causes damage to the Vehicle due to inadequately secured cargo; (xvi) **on unpaved or very rough roads**; or (b) failing to summon the police to any accident involving the Vehicle that caused personal injury or property damage; (c) damaging the Vehicle by your intentional, wanton, or reckless conduct; (d) damaging the Vehicle by an animal transported in the Vehicle; (e) **using the awning** if not allowed by owner (f) damaging the Vehicle by sitting, standing, or lying on the roof of the Vehicle; (g) damaging the Vehicle by placing tire chains, signs, lettering or painting on the outside of the Vehicle; (h) damaging the Vehicle by placing speakers or other sound equipment on the exterior of the Vehicle; (i) **taking the RV to Burning Man, Black Rock Desert, Sturgis, Death Valley or any restricted areas, EDC or any festival or special event without prior consent (Electric Daisy Carnival music festival)**; (j) **disabling the GPS** if so equipped, (k) carrying guns, ammunition or large knives.

45. We may use your deposit to pay any monies owed to us under this Contract.
46. You release us from all claims for, loss of, or damage to, your personal property or that of any other person, that we received, handled, or stored, or that was left or carried in or on the Vehicle, whether or not the loss or damage was caused by our negligence or was otherwise our responsibility.
47. No term of this Contract can be waived or modified except by a writing that we have signed. This Contract constitutes the entire Contract between you and us. All prior representations and Contracts between you and us regarding this Rental are merged into this Contract. The laws of the state of **Nevada** and **Clark County** govern this Contract.
48. If **optional add-ons, equipment, and convenience items** fail to work during a trip, no adjustments will be made to your charges. No troubleshooting by the Property Manager(s) or Owner(s) during the trip will be done for these items if there are issues. These include but are not limited to TVs, antennas, CD and DVD players, radios, satellite radios, satellite dishes, battery packs, GPS navigation hardware and software, hair dryers, fans, coffee makers, vacuum cleaners, artificial fireplaces, swiveling seats and left/right/rear cameras. If equipment provided during the rental period is deemed to be broken, missing, or damaged, the replacement cost will be the current retail price plus a **20% restocking fee**. You will not hold us liable for any injuries or accidents caused by add-ons or equipment supplied with the rental.
49. A waiver by us of any breach of this Contract is not a waiver of an additional breach or waiver of the performance of your obligations under this Contract. Our acceptance of payment from you or our failure, refusal, or neglect to exercise any of our rights under this Contract does not constitute a waiver of any other provision of this Contract. Unless prohibited by law, you release us from any liability for consequential, special, or punitive damages in connection with this Rental or the reservation of a vehicle.
50. You will indemnify, defend, and hold us harmless from and against any claim arising out of unsafe fueling practices committed by you or your agent. If any provision of this Contract is deemed void or unenforceable, the remaining provisions are valid and enforceable.

By signing below, you acknowledge that you have been given the opportunity to read this Rental Contract in its entirety, including the Terms and Conditions before being asked to sign. Your signature authorizes us to process payment from you for all charges due under this Contract, including later payment of any traffic, toll, or parking violations assessed against the Vehicle.

Addendum 1

RETURN INSTRUCTIONS

*We hope you enjoyed your time in Nomad's RV! Before you go and to **avoid additional post-trip fees**, the RV must be returned in the condition you received it, please follow the instructions below...*

1. **RETURN** the motor home between 9:00 am and 2:00 pm. If the motor home has any damage, please return before noon. A late fee will apply if returned late at **\$ 85.00** per hour.
2. **BEFORE** returning the RV; at the last campground or overnight stop:
 - a. Dispose of any left-over food and trash (trash removal fee will be charged if not disposed of) or we can dispose of trash for you for a **\$ 100.00** trash disposal fee.
 - b. Pack your personal belongings and luggage.
 - c. Clean the inside (shower, toilet, sinks, refrigerator, stove, oven, microwave, dishes, pots, pans, coffeemaker, and any add-on must be wiped clean) and sweep/mop the motor home. Use rags and the cleaning solution provided to wipe down surfaces. **DO NOT** use bath towels. **DO NOT** use abrasive sponges or harsh cleaners like bleach to clean. Using harsh cleaners can cause damage to surfaces, gray water tanks, and sensors. Clorox disinfecting wipes are safe to use. We can clean for you at **\$ 75.00** per hour. *The cleaning fee is not to be mistaken for the deep cleaning fee which starts at **\$ 350.00** minimum see the rental agreement for the definition of deep cleaning.
 - d. Restore seat belts to their original position on the couch and dinette. Check under the couch if present.
 - e. Replace any items removed from the RV or moved to different locations.
 - f. Drain the waste water tanks. The tanks must be empty! We can dump tanks for you, for a **\$ 150.00** dumping fee.
TIP: Clean up before dumping tanks, to avoid having to dump a second time.
3. **RE- FUEL** unleaded gas only. Make sure you re-fuel within a **five-mile** radius or we can refuel at **double the current fuel charge per gallon.**
4. **RE-FILL** propane tanks or we will refill them for you at **\$15.00** per quarter tank. Gage must-read FULL. (verify the tank indicators!).
5. **LINENS**, **DO NOT** remove bedding, toppers or covers leave bedding on beds. If the mattress protector is removed or stained and needs to be replaced it will incur a replacement fee. It is extremely difficult to replace and remove mattress protectors. Leave soiled towels in the shower and **DO NOT** use bath towels to clean the RV. We professionally launder the linens but even some stains cannot be removed, any heavy soiled or stained bedding that cannot be cleaned will incur a replacement cost. **Tip: shoe prints cannot be cleaned, avoid standing on bedding with shoes.**
6. **EXTERIOR**, if the exterior and undercarriage are excessively dirty, there will be an undercarriage mud removal fee of **\$ 75.00** and an exterior cleaning fee of **\$ 75.00**. Buffing of scratches will incur additional costs see rental agreement.
