**Security Deposit**. A \$500.00 security deposit (the "Security Deposit") is required for each camping trailer rental and due seven days prior to the day of the Rental Period Start Date. This security deposit covers the cost in the event there are missing or damaged items inside or damages to the outside of the camping trailer during your stay. If necessary, additional costs associated with missing or damaged items inside or outside the camping trailer may be charged to your credit card that we have on file. The security deposit may also be used to pay any monies owed to IT'S A WONDERFUL RV LIFE under this Agreement.

**Reservations**. For reservations made 30 days in advance, 100% of the total amount of your stay is due 30 days prior to your scheduled Rental Period Start Date and is non-refundable.

**Rescheduling**. If you must cancel your reservation and you are within 30 days of the Rental Period Start Date, you may reschedule your reservation for a fee of \$50. You must notify IT'S A WONDERFUL RV LIFE of your desire to reschedule and pay the \$50 rescheduling fee within 30 days of the Rental Period Start Date. The deposit that you placed toward your cancelled reservation will be applied to your rescheduled reservation. You have one year from the date you pay the \$50 rescheduling fee to reserve and occupy a camping trailer from IT'S A WONDERFUL RV LIFE or you will forfeit your deposited amount.

# TERMS AND CONDITIONS SIGN AND RETURN WITH RENTAL AGREEMENT

THIS MOTORHOME RENTAL AGREEMENT AND RELEASE OF LIABILITY, made and entered into at Kenwood, Ohio by, as of the date listed herein below, by and between **It's a Wonderful RV Life** (hereinafter referred to as "RV Rental") and the undersigned parties (hereinafter referred to as "Renters"); WITNESSETH: That

WHEREAS, RV Rental is willing to rent a motorhome or also referred to herein as a RV to Renters subject to the terms and conditions more particularly set forth herein; NOW, THEREFORE, in consideration of the foregoing premises and in consideration of the mutual undertakings and obligations hereinafter set forth, and intending to be legally bound the parties hereto agree as follows:

# 1. Definitions.

"Agreement" means all terms and conditions found in this form, any addenda and any additional materials we provide at the time of reservation/rental. "You" or "your" means the person identified as the renter on this form, any persons signing this Agreement, and any person or organization to whom charges are billed by us at its or the renter's direction. All persons referred to as "you" or "your" are jointly and severally bound by this Agreement. "We", "our" or "us" means It's a Wonderful RV Life. "RV" means motorized camping trailer identified in this Agreement. "Loss of use" means the loss of our right to use the Trailer for any reason because of damage to it or loss of it during this rental. Loss of use is calculated by multiplying the number of days from the date of damage to the Trailer until it is repaired or replaced time the daily rental rate.

#### 2. Rental, Indemnity, and Warranties.

This is a contract for the temporary use of the RV at the Rental Location noted above. This contract does not provide you or any other party with the right to tow or otherwise move the RV beyond the route to and from the pick-up location and the Rental Location. Unauthorized movement of the RV will result in, at a minimum, a loss of the Security Deposit and, potentially, legal action. We may repossess the RV at your expense without notice to you if the RV is abandoned or used in violation of any applicable laws or this Agreement. You agree to indemnify us, defend us and hold us harmless from all claims, liability, costs and attorney fees we incur resulting from, or arising out of, this rental and your use of the RV. We make no warranties, express, implied or apparent, regarding the RV, no warranty of merchantability and no warranty that the RV is fit for a particular purpose.

#### 3. Rental Rate and Policy

The motorhome rental rate is \$325.00 per night with a four-night minimum on Renters reserved campsite (five night minimum on holidays). There is a \$3 a mile delivery and setup fee.. Additional delivery charges may apply.

# 4. Reservations Deposit/ Payment and Cancellation Policy

The remaining rental rate balance as well as the security deposit is required to be paid by Renters at the time of delivery/check-in pursuant to the following provisions:

a.) Paypal, Venmo, cash, check, or money order is accepted.

b.) Full refund of reservation deposit will be returned up to 30 days before the reserved date minus a \$25.00 cancellation fee.

c.) No refund of reservation deposit to Renters within two weeks of reserved date.

d.) In the event of cancellation within 30 days, Renters will be charged the full rental amount.

# 5. Security Deposit

A \$500.00 security deposit is required to be made by Renters at the time of check-in. The deposit will be refunded within seven business days after the rental if the terms of the rental agreement are met and the motorhome is clean and undamaged with all invento- 2 ry items in place. The motorhome must be clean and undamaged; otherwise the entire deposit will be forfeited by Renters. Cash,money order, Venmo, PayPal of Check will be accepted.

#### 6. Post Rental Fees

Once the RV is returned post fees will be assessed and billed for the below fees as incurred. Post-trip Fees - Post-trip fees can be added at the discretion of the owner once they have had the opportunity to assess the condition of the RV when returned by the renter. Owners have 72 hours to submit the Return Form after the reservation ends, and you will receive an email notification when the form is submitted. Post-trip fees include overages on mileage or generator hour allowance, expenses such as tolls or traffic violations, damages to the RV, and the additional fees listed below:

- \$150.00 Cleaning Fee We understand that RVs get dirty out on the road. Returning an RV with a
  normal amount of dirt is acceptable and will not result in any additional charges. However if an RV
  is returned covered in dirt, soot, trash, food, wine stains, etc, and the RV is not cleaned prior to
  returning it, the owner may choose to charge an additional cleaning fee.
- \$50.00 Dumping Fees The responsibility for dumping the waste tanks should be determined prior to the start of the trip. If the tanks are not dumped by the renter, the owner can choose to charge an additional dumping fee that can include the cost of dumping the tanks as well as a charge for the act of dumping the tanks.
- \$325 per night Late Fee If a renter returns the RV after the agreed upon drop off time plus a one hour grace period, the owner may choose to charge a late fee for the reservation. RVs that are returned eight hours or more late without consent from the owner can be charged for an extra rental night.
- \$150.00 Refueling Fee Expectations for refilling propane and gas tanks should be set prior to the start of the trip. If the fuel refill requirements are not met the owner can choose to charge an additional fuel refill fee that can include both the cost of the fuel as well as a charge for the act of refilling the tanks.
- \$500.00 Abandonment Fee If the RV is not returned to the place of pick up or another location that the owner agreed upon, an abandonment fee may be charged by the owner
- \$100.00 Linen Fee- For the use and cleaning of the bedding and towels.

# 7. Campground Reservations.

We are not responsible for campground reservations. All campground reservations must be made separately with the campground reservation agency. All campground and campsite fees are separate from and in addition to the rental price and fees under this Agreement. No refunds will be given for campsite reservation errors.

# 8. Check In.

Delivery times are generally between 12noon- and 6:00 p.m.. daily. It is your responsibility to call us at (513) 667-3700 on the Rental Period Start Date to check in with our office and receive your scheduled pick-up/delivery time. Delivery times will be scheduled on an availability basis.

#### 9. Delivery / Set up / Pick up.

We will deliver and set up the RV at the Rental Location on the Rental Period Start Date and pick up the RV upon completion of your Rental Period. There is a \$3 a mile delivery and setup fee. Additional delivery charges may apply, such as a minimum \$35.00 delivery fee. At the time of delivery, one of our staff members will provide you with an orientation to show you the safe and proper use of the RV and its features. Additionally, the orientation will provide a summary of the prohibited uses of the RV. The RV will include instruction booklets which will explain the operation of the RV and its features, as well as provide campground rules. The orientation process can take up to one (1) hour - please allow yourself enough time. There are no refunds for early departures. If incorrect delivery information is submitted through the reservation request form that results in delivering your rental on the wrong date or to the wrong space/location, \$100 will automatically be deducted from your security deposit to cover travel costs & time spent.

#### 10. Return and Cleaning

The RV must be returned without damage and the inside must be clean prior to check out (dishes washed, dried, and put away, trash removed, floors swept, and countertops wiped). Failure to return without damage and/or in an unclean state will result in additional charges that may be deducted from the Security Deposit and, if necessary, additional charges may be made to your credit card.

#### 11. Cleanliness

In between rentals, we clean all high contact surfaces with soap and water first and then hydrogen peroxide (FDA approved for COVID-19) on all contact surfaces. Then we wait 10 minutes till wiping clean. Then we use soap and water to clean again. A steam mop is used for all flooring. During rentals we provide Myers soap and cleaners. All sheets, bedding, and towels are cleaned on hot water with All Free and Clear detergent.

#### 12. Valid Driver's License

An acceptable, valid driver's license issued from your country of residence must be presented at the time of rental. The driver's license must be valid for the entire rental period. If the driver's license is in a language other than English, an International Driver's Permit is recommended or other form of identification that we find acceptable.

- All drivers must possess a valid drivers license for the entire rental period.
- Minimum age is 25 years old.
- Only drivers listed on the contract are allowed to drive.
- A special license is not required.

#### 13. Insurance

The renter must show proof of valid and enforceable car insurance as well as book the insurance services from RVSHARE or OUTDOORSY.

#### 14. Acceptable Forms of Payment

Payment for the rental should be made to RVShare or Outdoorsy. A copy of your current driver's license or car insurance must be submitted at time of the rental. Security deposits can be made by either cash, check, cashier check, Venmo, or PayPal.

#### 15. Prohibited Uses

The following acts and/or uses are prohibited and constitute a breach of this Agreement Subject, but not limited to, forfeiture of the security deposit, repossession of the RV without legal process, and/or legal action:

a) any music festivals

b,)the unauthorized towing, moving, pulling or other prohibited use of the RV;

c) accessing or walking on the roof of the RV; and

d) not complying with all campground rules and regulations, or State or federal laws.

#### 16. Personal Property

You release us, our agents and employees from all claims for loss of, or damage to, your personal property or that of any other person, that was left or carried in or on the RV or in our offices, whether or not the loss or damages was caused by our negligence or was otherwise our responsibility.

#### 17. Personal Injury

You release us, our agents and employees from all claims for injury, including, without limitation, personal, bodily, or mental injury, economic loss or damage to you, guests, unborn children, or relatives, whether or not the injury was caused by use of the RV, our negligence, or was otherwise our responsibility.

#### 18. Limited Supplies.

Most trailers come equipped with oversized tanks - approximately forty (40) gallons of fresh water, ninety (90) gallons of grey and black water holding tank capacity, 8 pounds pounds of propane, and two (2) 12 volt house batteries. It is your responsibility to ensure that these resources last your entire rental period. We will not provide customers additional water, holding tank capacity, propane, or batteries during their rental period. Many Loves and Pilots have RV dump stations and propane refills.

#### 19. Fuel

When filling the RV only use 85 unleaded fuel. **To refill you must turn off the propane**. Most fill stations will only let you fill \$75 at a time. You can fill more if you do another transaction typically. The RV should be returned with the same amount of fuel that it was delivered in.

#### 20. Generator

The RV comes equipped with a gasoline powered generator. The generator supplies 110 volt power to the outlets in the RV. The generator also supplies power to the RV's microwave oven and roof air conditioner. The generator can be used to recharge the RV's two 12 volt batteries. The RV's generator runs off the RV's gas tank. You must have at least ¼ a tank to run the generator. Once it reaches a ¼ a tank the generator shuts off until it is refueled. We try to have at least a half a tank to full tank when rented to you. It is your responsibility to refuel the gas tank to the level you will need. Fuel at time of rental is

\_full.

# 21. Set-Up Check-List

- 1. Put the RV in park and engage the parking brake.
- 2. Turn off the ignition but turn the ignition back on to engage the battery.
- 3. Go to the auto-leveling controls by the back door. Chuck the wheels.
- 4. Hit AUTO-LEVEL and do not move.
- 5. If the AUTO-LEVEL fails to complete use the leveling blocks in the outside compartment by the driver's door to complete the process. Place them under the auto level system.
- 6. Remove the keys from the ignition.
- 7. If plugging in, use the surge protector to first check the line. Plug in the surge protector. Turn on the 30 AMP power. Wait for the green light. Turn off the power and then plug in the surge protector and then the RV. Turn the 30 AMP power switch back on.
- 8. Connect the water using the water pressure regulator and water filter. Turn the dials to city connection. Make sure the water pump is on.
- 9. If using sewer, use the elbow connector and then the sewer line. We keep the lines closed until the grey is filled and then flush the black and then the grey.
- 10. Check the entire inside length of the slide to make sure it is clear of any objects. Also, check the outside to make sure you have 3 feet of clearance to open the slide.
- 11. Open the slide.
- 12. Set-up complete!

#### 22. Appliances

The A/C, generator, awning, radio, microwave, television, jacks, etc. are convenience items. If any malfunctions should occur with any of these items, no compensation will be made to you. For assistance, you are advised to consult the informational material in the RV or give us a call at (513) 667-3700.

# 23. Fridge

The Fridge must be **LEVEL** while Motorhome is **STATIONARY**. Air Bubble in Level (in bottom of freezer) must touch the inner ring.

# 24. Gas Stove and Microwave

When using the gas stove the outside vent must be opened to prevent fire and Carbon Dioxide poisoning. There is a carbon monoxide alarm below the fridge. If this is red and beeping, you need to exit the RV and turn off the gas. Once the gas is off and it is safe to enter the RV, you should open all the windows and run all the fans. To turn on the stove you hold the far left knob in and turn the dial you want on at the same time.

#### 25. Water Usage and Toilet

The RV motorhome is equipped with a gray water holding tank that collects water from the shower and sinks. The black water holding tank collects water from the toilet. If Renters are staying in a site without full hookups, they should use water sparingly so as not to exceed the tanks holding capacity. We suggest using the shower facilities in the campground bathhouse. If the holding tanks are filled to capacity, there will be a fee of \$50.00 for us to empty the tanks after the rental. Many Pilots and Loves offer dump stations as well as campgrounds. The water or toilets cannot be used once the gray and or black tank capacity is exceeded. **ONLY RV TOILET paper goes down the RV TOILET.** 

# 26. Dumping

When dumping, empty the black water first and then the grey water to flush the system. There will be a fee of \$50.00 for us to empty the tanks after the rental. Rentalers should return the RV with the black and grey tanks empty.

**27. Inventory Items** The motorhome is stocked with many items. Loss of any item will be charged \$15.00 per item plus the cost to replace the item.

#### 28. Linens and Paper Products

We provide all the linens and paper products needed for a standard rental for \$100.00 a rental. Additional needs of foreseen linens or products will need to be purchased by the renter. We provide the linens for the two full beds and two bunk beds. Anything beyond that is the responsibility of the renter.

#### 29. Canopy

The canopy is subject to wind damage if left out during windy conditions. It is advisable to retract the awning when Renters are away from the campsite. Storms can come up suddenly during the summer resulting in wind gusts that can destroy the canopy. If the canopy is damaged due to negligence on Renters part, then Renters Will be obligated to pay for repairing the canopy.

#### 30. Slide

Slide(s) MUST be closed on the RV prior to moving the RV any distance. Renter will be responsible for any damages that occur due to not retracting the slide(s) prior to moving.

#### 31. Smoking

Smoking is not allowed within the motorhome. Renters and their guests are required to exit the motorhome when smoking. If the smell of smoke is detected during the inspection, then Renters deposit will be forfeited, plus any additional charges incurred in cleaning and/or repair.

#### 32. Pets

Pets are not permitted in the RV. Renters will forfeit all deposits if motorhome is unclean or damaged in any way by pets.

#### 33. Renter Damage

If the RV and/or the contents in the RV at the time of the delivery orientatio are damaged during your rental period, you are responsible to pay all damage costs whether you were at fault or not or if damage was caused by acts of nature (wind, rain, earthquake, fire, flood, etc). If an accident occurs, you are responsible for obtaining a police report, contacting the other party's insurance company and contacting us immediately at (513) 667-3700. At check out, IT'S A WONDERFUL RV LIFE will estimate the damage, if any, and expedite the cleaning and/or repair.

# 34. Early Departures/ Extending Rental Dates

You are responsible for reviewing this Agreement to ensure that all rentals costs and rental dates are correct. If you wish to extend the rental period, you must call us for approval. There are NO refunds for early departures. If you do not vacate at the scheduled check-out time on the scheduled Rental Period End Date and you have not called us for approval to extend the rental period, you will be charged additional rental day(s), and any inconvenience fees incurred by the next renter.

# 35. Milage

Motorhomes receive a travel allowance of 100 miles per day. Additional mileage will be charged at \$0.35 a mile.

# 36. RELEASE OF LIABILITY, PROMISE NOT TO SUE, ASSUMPTION OF RISK AND AGREEMENT TO PAY CLAIMS

In consideration for being allowed to participate in the renting of the motorhome, at the times and locations provided below, on behalf of Renters, Renters' guests, next of kin, heirs, and/or representatives, release from all liability and agree not to sue RV Rental It's a Wonderful Rv LIfe or Jebb Lyons or Danielle Lyons from any and all claims including claims regarding Danielle Lyons and Jebb Lyons' negligence, resulting in any physical or psychological injury (including paralysis and death), illness, damages, or economic or emotional loss Renters, Renters' guests, next of kin, heirs, and/or representatives may suffer because of their participation in renting the motorhome, including traveling and any other during activities. Renters are voluntarily participating in this the renting of the motorhome and are aware of the risk associated with participating in such activity which includes, but is not limited to, physical or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent disability including (paralysis), economic or emotional loss, and/or death. Renters understand that these injuries or outcomes may arise from their own or others actions, inactions, or negligence. Nonetheless, Renters assume all related risks, both known or unknown to Renters, associated with their participation in this activity, including travelling during the activity. Renters further agree to hold It's a Wonderful RV Life and Danielle Lyons and Jebb Lyons harmless from any and all claims, including attorney's fees or damage to Renters personal property, that may occur as a result of Renters participation in this activity, including travel to, from and during the activity. If Wonderful RV Life and Danielle Lyons and Jebb Lyons incurs any expenses regarding the aforesaid, Renters agree to reimburse Wonderful RV Life and Danielle Lyons and Jebb Lyons for said expenses. If Renters need medical treatment, Renters agree to be financially responsible for any and all costs incurred as a result of such treatment. Renters are aware and understand that they

should carry their own health insurance. 4 Renters are 25 years or older. Renters understand the legal consequences of signing this document, including: (a) releasingWonderful RV Life and Danielle Lyons and Jebb Lyons from all liability; (b) promising not to sue Wonderful RV Life and Danielle Lyons and Jebb Lyons and (c) and assuming all risks of participating in this activity, including travel to, from and during the activity. Renters understand that this document is written to be as broad and inclusive as legally permitted. Renters agree that if any portion is held invalid or unenforceable, Renters will continue to be bound by the remaining terms. Renters have read this document, and by initialing below and submitting this form electronically, Renters are signing it freely. No other representations concerning the legal effect of this document have been made to Renters.

#### 37. Waiver

Our failure to enforce any of our rights under this Agreement or at law shall not be deemed a waiver or a continuing waiver of any rights or remedies against another party, unless such waiver is in writing and signed by the party to be charged.

# 38. Governing Law and Venue

This Agreement Shall be interpreted and enforced according to the substantive laws of the State of Ohio without application of its conflicts or choice of law rules. Both parties irrevocably submit to the jurisdiction of the state court located in Hamilton County, Ohio or the federal court located in for any action of proceeding regarding this Agreement, and both parties waive any right to object to the jurisdiction, forum or venue of the Ohio state court located or the Ohio federal court.

# 39. Severability

If any provision of this Agreement is judicially determined to be invalid, void or unenforceable, the remaining provisions shall remain in full force and effect.

#### 40. Attorneys' Fees

In the event a dispute arises regarding this Agreement, the prevailing party shall be entitled to recover its reasonable attorneys' fees and costs, in addition to other relief to which it is entitled.

#### 41. Modifications.

No term of this Agreement can be waived or modified except by a writing that we have signed.

# 42. Entire Agreement.

This Agreement constitutes the entire agreement between the parties regarding the rental of the Trailer, and supersedes all prior oral or written agreements or understandings regarding this subject matter. This Agreement can only be amended by a writing signed by all parties. Initials

# 43. Refunds.

No refunds will be given for any reason, including, but not limited to, bad weather, no shows, late arrivals, or early departures.

- Renters are entitled to a full refund, less the RVshare service fee, for all cancellations made at least 30 days prior to the rental start date.
- Less than 30 days prior to the rental start date, the booking is non-refundable.

• A 24-hour cancellation grace period is given to all bookings made at least 7 days prior to the rental start date. For all bookings made within 7 days of the rental start date, a 1-hour grace period is given. If a booking is cancelled during a grace period, a full refund including the RVshare service fee will be granted.
