1.	NO SMOKING: Smoking (including cigars, pipes, vapes, drugs, incense etc.) in the unit forfeits your entire security depositinitial
2.	NO DRUGS: Any evidence of the storage, transportation, or use of illegal substances will forfeit your entire security deposit. Travel trailers returned with any evidence of drug use, or transportation of drugs will result in law enforcement being contactedinitial
3.	PETS: We camp with our dog and allow pets in the camper. Leaving your pet unattended inside the camper is not recommended and highly discouraged. Any damaged caused by your pet will result in our pet damage fee of at least \$250initial
4.	FESTIVALS/LARGE EVENTS: Must have pre-approval. This unit is not be used for or to attend any organized, or unorganized festivals or events/gatherings (e.g.; music festivals, race events, etc.)initial
5.	Odors / Cooking: We do NOT allow anything that can create a strong smell in the camper that is difficult to remove, such as raw fish storage, or cooking. This camper has an outside cooktop and should be used for these types of occurrences. No frying inside. Bacon cooks well in the oven or on the outside burnersinitial
6.	NO Generator Usage: Using a generator is not allowed. We do not provide and do not allow for generator use. Evidence and/or damage from generator use will result in full or partial security deposit forfeitureinitial
7.	AWNING: All awnings must be retracted every night and when you are not physically located with the camper. As weather patterns can change quickly, the awnings are easily susceptible to damage from high winds or hail. Replacement or repair costs for awnings can quickly exceed \$3,000 - \$4,000. Awnings are not covered by insurance, and damage will be the responsibility of rentersinitial
8.	Cleaning: We sanitize between every rental to help protect the safety and well being of all guests; however, we do ask that you return the camper in a clean and tidy manner. Including removal of all trash, cans, personal belongings. Excess cleaning, trash or food removal will result in an additional and automatic \$50 feeinitial
9.	Any personal belongings left behind that you want returned will be an additional \$20 fee (This will cover sending these items back to you the renter)initial
10.	Propane: We provide two full tanks. Depending on your length of stay be mindful of usage. Additional trips to refill/swap out tanks is \$50initial
11.	Training: When we deliver the unit, we will complete a pre-rental orientation of the unit that can take up to 60 minutes, depending on any prior experience you have with a travel trailer Please plan for this when you first arrive.

12. Damage/Minor Repairs: Any damages need to be reported to us <u>immediately</u> . If the potential repair is minor, you may make the repair <u>after</u> consulting us and mutually agreeable. Replacement of defective parts and receipts must be brought back for reimbursement. There will be NO reimbursement if you do not bring back the defective pyou replaced and the receipt. If you purchase an item necessary due to an equipment failure (sewer or water hose, etc.) the item you purchased and the receipt must be surrendered upon return if you want reimbursementinitial	oart
13. Interior Damage: Depending on the coverage selected at the time of rental. Any damage done to the interior of the camper is typically not covered. Any damage found upon return that was not documented at pick-up will be the responsibility of the renterinitial	
14. Security Deposit: Your security deposit is refunded after the unit is checked in, and there no damage or issues requiring funds from the depositinitial	e is
