I, (print name) _____ understand and /or certify that:

1. I have read and fully understand this entire contract and all policies therein.
2. I am responsible for having proper trailer hitch and vehicle towing capacity for the camper trailer rented. Company reserves the right to deny the check---out and use of any trailer to any Renter for reasons of personal safety and prevention of equipment and/or property damage.
3. If applicable, I have been provided the specific Camper Trailer and understand all policies and limitations specified therein.
4. I currently possess and will maintain the minimum insurance coverage required by the State of MI that covers damage and liability to a rented travel trailer, boat & trailer, or utility trailer and will provide proof of such to MIKES RV SERVICE LLC.
5. I understand the guidelines and safety regulations concerning use of propane fueled appliances. And I further understand the risk of carbon monoxide poisoning and fire related injuries that result from the improper use of these appliances.
6. MIKES RV SERVICE LLC requires a \$500 refundable security deposit required at the time of departure. Additionally, my credit card shall be held in file. Security Deposit may be charged against any costs associated with missing or damaged items inside or outside of the trailer during your stay and/or cleaning fees to return property to the condition in which it was checked out. If necessary, additional costs associated with missing or damaged items inside or outside the camping trailer may be charged to your credit card on file.
7. Operating lanterns, mobile heaters, and any open flame (i.e. candles, incense, etc.) are prohibited inside campers.
8. Travel trailers with water/waste storage tanks must be returned with all tanks empty. If not, a fee of \$100 will be incurred.
9. Smoking is strictly prohibited in any enclosed camper or trailer. If there is indication of smoke odor, a fee of \$250 will be incurred.
10. NO PETS are allowed in the travel trailers. Any indication of pets, such as odor, pet hair, or stains shall incur a fee of \$250 to clean or replace damaged items.
11. Towing a trailer requires me to adjust my driving speed and habits in accordance with local laws and to avoid damage to property or personal injury.
12. There are inherent risks involved with towing trailers and will comply with all federal and state regulations regarding safe driving and operation of towed equipment. I recognize MIKES RV SERVICE LLC strongly recommends that customers DO NOT tow trailers in hazardous conditions or poor weather. As such, I take full financial responsibility of all property damage or personal injury, no matter how minor.
13. MIKES RV SERVICE LLC recommends these trailers operate in state of MICHIGAN only and MIKESRV RV SERVICE LLC strongly discourages the taking of any Company property outside of the state. If any Company property is taken outside of MICHIGAN without the written permission of the Company, and the customer is unable to bring said property back to the Company facility for any reason, the customer shall be 100% financially liable to have the vehicle safely returned to Company's storage sight at 9439 Marine City Hwy, IRA, MI, 48023.
14. Violations of the Company policy terminates all conditions, excluding financial obligation, of your rental agreement, places you responsible and will result in termination of future rental usage.
