

RV Rental Agreement

This Rental Agreement is made and entered into as of _____, by and between Brandon Brown, ("Owner") and _____, ("Renter").

1. Rental Vehicle

The Owner agrees to rent to the Renter the recreational vehicle described as follows:

- Make and Model: Winnebago Solis
- Year: 2021

2. Rental Fee

The total rental fee is \$ _____ Per Day Plus \$150 Cleaning, payable as follows:

- Initial Payment: \$500 due upon signing this Agreement.
- Balance: Balance due on Return Date.

3. Security Deposit

A security deposit of \$250 is required at the time of pick-up. This deposit will be refunded upon return of the RV, less any deductions for damages or additional cleaning required.

4. Cancellations

Cancellations must be made at least 7 days before the start date to receive a full refund of the deposit. Cancellations made less than 7 days before the start date will result in forfeiture of the deposit.

5. Use of Vehicle

- The Renter agrees to operate the RV in a careful and proper manner and abide by all laws and regulations.

- The RV shall not be used for any off-road activities.
- No smoking is allowed inside the RV.
- Pets are not allowed inside the RV at any time, and any evidence of pets in the vehicle will incur a \$500 fee.

6. Maintenance and Breakdowns

The Renter is responsible for daily checks on the RV's basic maintenance needs during the rental period. In case of a mechanical failure, the Renter must notify the Owner immediately.

7. Insurance

The Renter assumes all liability for damage to the RV or injuries to persons during the rental period. The Renter is required to provide their own insurance coverage for the duration of the rental and must furnish proof of insurance to the Owner prior to taking possession of the RV. The Renter's insurance must cover liability, comprehensive, and collision damage. The Owner is not responsible for any damages or liabilities incurred during the rental period.

8. Return of Vehicle

The RV must be returned on the specified date and time. The Renter is responsible for returning the RV in the same condition it was received, barring normal wear and tear.

9. Liability

The Owner shall not be liable for loss or damage to any property left, stored, or transported by Renter or any other person in or upon said vehicle either before or after the return thereof to Owner.

10. Entire Agreement

This Agreement constitutes the entire agreement between the parties. Any modifications or amendments must be in writing and signed by both parties.
