- 3. You agree to pay a gasoline and a propane fee of **\$49 each**, plus the actual cost of propane or gasoline to refill the propane or gasoline tank if it is returned less than full.
- 4. **Smoking/vaping/illegal drug use or glitter is <u>prohibited</u> in the vehicle.** Suppose there is evidence of smoking, vaping, illegal drug use, glitter, or strong odors. In that case, you will be subject to the additional cleaning fee of up to <u>\$399</u> plus potential forfeiture of your entire security deposit at the manager's/owner's discretion.
- The refundable security deposit for this rental is \$1,900.
- 6. No refund will be given if you prepay for a service but do not use it.
- 7. You agree to pick up the vehicle at the specified location at the pre-arranged time. A late pickup fee of \$65 per hour will be charged for each hour that the vehicle is picked up late. If extenuating circumstances exist, this fee may be waived at the Owner(s)' sole discretion.
- 8. You agree to return the RV by the agreed upon time, but no later than <u>5:00 PM</u> Central Standard Time, on the return date of __/__/2023. Unless arrangements have been made for a late return, a \$65 per hour late fee will be charged for each hour that the vehicle is returned later than the pre-arranged time. If extenuating circumstances exist, this fee may be waived at the Owner(s)' sole discretion.
- 9. We have <u>72</u> hours from when you return the RV to inspect it for damage not noticed at check-in. You have <u>72</u> hours from when we submit the final check-in forms to dispute any damages or other charges.
- 10. You release the (Owner(s) from all claims for loss of, or damage to, your personal property or that of any other person which is left or carried in the vehicle.
- 11. You agree to pay us on demand for all charges due us under this Contract, including but not limited to (a) time for the period during which you take the Vehicle; (b) there are no charges for additional drivers; (c) charges for the optional services; (d) applicable taxes if any; (e) all traffic, toll or parking violations, fines, penalties, citations, forfeitures, court costs, towing charges and other expenses involving the Vehicle assessed against us or the Vehicle; if you fail to pay a traffic or toll charge to the charging authority, you will pay us all fees owed to the charging authority; (f) \$499, plus \$0.39/mile for every mile between the renting location and the place where the Vehicle is returned, repossessed or abandoned, plus any additional recovery expenses we incur; (g) all costs, including pre-and post-judgment attorney fees, legal fees and court costs we incur collecting payment from you or otherwise enforcing our rights under this Contract.
- 12. You have truthfully disclosed the identity and proper age of all drivers.
- 13. You agree to return the vehicle in the same condition in which it is received. This includes an odor-free and clean interior of the RV.
- 14. You agree that towing requires prior approval.
- 15. You are responsible for checking and maintaining all fluid levels during the rental period. This includes checking the generator oil weekly if you use the generator.
- 16. Unless authorization is obtained from the owner(s), no repairs, replacement of parts, or service shall be completed during the Rental period.
- 17. The owner(s) are **not** responsible for the loss of vacation, personal or business time, or any incidental expenses incurred by the renter resulting from a breakdown or any other delay problems. The owner(s) shall be responsible for completing any necessary repairs and returning the vehicle to Rental condition as promptly as possible.
- 18. You agree not to take the vehicle outside the continental United States.
- 19. You are responsible for reporting all accidents, incidents of vandalism, or theft to the police and the owner(s) upon discovery.
- 20. You agree that all driver information has been reported accurately and that no unauthorized drivers shall operate the vehicle. All reported drivers must have a valid driver's license.
- 21. You agree that all insurance information (if applicable) provided is valid.
- 22. You agree that Vehicles shall not be driven off-road or on unpaved surfaces or very rough roads of any type.
- 23. We may use your security deposit to pay any amounts owed to us under this Contract, which shall include replacement of fuel or LP gas, wastewater dumping, loss or damage to the vehicle, administrative or legal fees, fines, penalties, forfeitures, court costs, towing and storage charges, and other assessed charges unless the expenses are our fault, all costs associated with locating and recovering the vehicle if you fail to return the vehicle as required by the terms of the Rental Contract. If the amount of your security deposit is insufficient to satisfy all amounts due, then you agree to pay all charges in excess.
- 24. This is a contract for the Rental of the Vehicle. We may repossess the Vehicle at your expense without notice if the Vehicle is abandoned or used in violation of law or this Contract. You agree to indemnify us, defend us, and hold us harmless from all claims, liability, costs, and attorney fees we incur resulting from or arising out of, this Rental and your use of the Vehicle.
- 25. We make no warranties, express, implied, or apparent, regarding the Vehicle, no warranty of merchantability, and no warranty that the Vehicle is fit for a particular purpose.
- 26. You must return the Vehicle to the place of pickup of other location that we specify, on the date and time specified in this Contract, and in the same condition that you received it, except for ordinary wear.
- 27. If the vehicle is returned after the specified time, you remain responsible for the safety of, and any damage to, the Vehicle until we inspect it.
- 28. The following acts or uses of the Vehicle are prohibited and may result in forfeiture of the entire security deposit: (a) driving the Vehicle: (i) by anyone who is not an Authorized Driver, or by anyone whose driving license is suspended in any jurisdiction; (ii) by anyone under the influence of drugs or alcohol; (iii) by anyone who obtained the Vehicle or extended the Rental period by giving us false, fraudulent, or

misleading information; (iv) in furtherance of any illegal purpose or under any circumstance that would constitute a violation of law other than a minor traffic citation; (v) to carry persons or property for hire; (vi) in any race, speed test or contest; (vii) to carry dangerous or hazardous items or illegal material; (viii) outside the United States; (ix) when loaded beyond its capacity, as determined by the manufacturer of the Vehicle; (x) when driven through or under an underpass or other structure without sufficient overhead or side clearance; (xi) when it is reasonable to expect you to know that further operation would damage the Vehicle; (xii) in a manner that causes damage to the Vehicle due to inadequately secured cargo; (xvi) on unpaved or very rough roads; or (b) failing to summon the police to any accident involving the Vehicle that caused personal injury or property damage; (c) damaging the Vehicle by your intentional, wanton, or reckless conduct; (d) damaging the Vehicle by an animal transported in the Vehicle; (e) using the awning in high winds; (f) damaging the Vehicle by sitting, standing, or lying on the roof of the Vehicle; (g) damaging the Vehicle by placing tire chains, signs, lettering or painting on the outside of the Vehicle; (h) damaging the Vehicle by placing speakers or other sound equipment on the exterior of the Vehicle; (i) taking the RV to Burning Man or EDC (Electric Daisy Carnival music festival); (j) disabling the DASHCAM or TPMS Tire Pressure Monitoring System

- 29. We may use your deposit to pay any monies owed under this Contract.
- 30. You release us from all claims for, loss of, or damage to, your personal property or that of any other person that we received, handled, or stored, or that was left or carried in or on the Vehicle, whether or not our negligence caused the loss or damage or was otherwise our responsibility.
- 31. No term of this Contract can be waived or modified except by a writing that we have signed. This Contract constitutes the entire Contract between you and us. All prior representations and Contracts between you and us regarding this Rental are merged into this Contract. The laws of the state of **Texas** and **Ellis County** govern this Contract.
- 32. Certain items are considered non-essential convenience items. If they fail to work during a trip, no adjustments will be made to your charges. No troubleshooting by the Owner(s) during the trip will be done for these items if there are issues. These include DASHCAM, TVs, antennas, CD and DVD players, radios, satellite radios, satellite dishes, battery packs, microwave ovens, stoves, hair dryers, fans, coffee makers, reclining seats, and left/right/rear cameras.
- 33. A waiver by us of any breach of this Contract is not a waiver of an additional breach or waiver of the performance of your obligations under this Contract. Our acceptance of payment from you or our failure, refusal or neglect to exercise any of our rights under this Contract does not constitute a waiver of any other provision of this Contract. Unless prohibited by law, you release us from any liability for consequential, special, or punitive damages in connection with this Rental or the reservation of a vehicle.
- 34. You will indemnify, defend, and hold us harmless from and against any claim arising from unsafe fueling practices committed by you or your agent. If any provision of this Contract is deemed void or unenforceable, the remaining provisions are valid and enforceable.

By signing below, you acknowledge that you have been allowed to read this Rental Contract, including the Terms and Conditions, before being asked to sign. Your signature authorizes us to process payment from you for all charges due under this Contract, including later payment of any traffic, toll, or parking violations assessed against the Vehicle.
