

**This RV Rental Agreement ("Agreement")** is entered into on this \_\_\_\_ day of \_\_\_\_\_, **20\_\_**, (the "Effective Date") between D & W Trucking and all its affiliates (collectively referred to as "Lessor") and the undersigned individual(s) or entity ("Lessee") collectively referred to as the "Parties".

**1. Rental RV Information:**

- **RV Description:** The Lessor agrees to rent to the Lessee the recreational vehicle ("RV") described as follows: 2019 THOR FREEDOM TRAVELER A30 VIN 1F65F5DY1J0A17007
- **Rental Period:** The rental period shall begin on [Start Date] at [Start Time] and shall end on [End Date] at [End Time]. Late returns are subject to additional charges as outlined in Section 3.

**2. Rental Fee, Security Deposit, and Other Charges:**

- **Daily Rental Fee:** The Lessee agrees to pay a daily rental fee of \$290.00 Sunday - Thursday for the entire rental period and \$310 for Friday-Saturday. With a two-day minimum rental period. 50% Payment shall be made in full prior to the commencement of the rental period.
- **Security Deposit:** The Lessee shall also provide a security deposit of \$500.00 at the time of booking. The security deposit is refundable upon return of the RV in the same condition as rented, subject to deductions for any damages, cleaning fees, or late return charges.

**3. Late Returns and Additional Charges:**

- **Late Return:** The Lessee acknowledges that late returns beyond the agreed-upon end date and time shall incur an additional charge of \$ 90 per hour.
- **Cleaning Fees:** The Lessee agrees to pay a \$350 cleaning fee upon return which will be deducted from the security deposit.
- **Damage Charges:** The Lessee shall be responsible for any damages incurred during the rental period, including but not limited to interior and exterior damages. Repair costs will be deducted from the security deposit.

**4. Insurance and Liability:**

- **Insurance Requirement:** The Lessee agrees to maintain comprehensive insurance coverage for the rented RV throughout the rental period. The insurance coverage must protect against all liabilities, including damages to the RV and third-party liabilities.
- **Release of Liability:** The Lessee hereby releases and indemnifies the Lessor and its affiliates from any and all liabilities, losses, damages, claims, or expenses arising out of or related to the rental, operation, or use of the RV.

**5. Driver Requirements:**

- **Authorized Drivers:** Only drivers listed and authorized in this Agreement are permitted to operate the RV. Additional drivers must be approved by the Lessor in writing.
- **Driver Qualifications:** All drivers must possess a valid driver's license and meet the minimum age requirement of 25 years.

**6. RV Usage Guidelines:**

- The Lessee agrees to use the RV in a responsible manner, adhere to all applicable laws and regulations, and not use the RV for any illegal activities.
- The RV shall not be subleased, lent, or rented to any other party without the explicit written consent of the Lessor.

**7. Termination of Agreement:**

- The Lessor reserves the right to terminate this Agreement and repossess the RV if the Lessee breaches any terms or misuses the RV.

**8. Governing Law:**

- This Agreement shall be governed by and construed in accordance with the laws of the State of California, without regard to its conflict of law principles.

**9. Entire Agreement:**

- This Agreement constitutes the entire understanding between the Parties and supersedes all prior agreements or understandings, whether written or oral.
