Trailer must be returned in the same condition as it was when picked up, clean and damage free. If the trailer is dirty or damage is found, a full deposit will not be returned. Any damage to the trailer or its contents caused by the renter or third party is to be reported to Dorian & Amy Funk immediately and repaired at renter's expense.

Trailer must be returned on the return date as stated in this agreement. If trailer is returned late, a \$150 per day late fee will be charged. There are no refunds for early returns.

THIS TRAILER IS NON SMOKING. IF CIGARETTE SMOKE SMELL IS DETECTED UPON RETURN RENTER MAY FORFIT FULL DAMAGE DEPOSIT.

Awning on trailer is the full responsibility of the renter. If there is any damage to the awning, repair or replacement will be at renter's expense. Do not leave awning out in windy or stormy weather. Do not hang or tie anything on awning or let children play near. Do not leave the awning unattended.

At no time should anyone ever climb up onto the roof of the trailer. This area is completely off limits.

Do not transport any items inside the trailer other than items included in the trailer.

Pets: We will allow small lap dogs only that are in a kennel or crate at all times inside the trailer. There is a \$50 pet cleaning fee per rental. Large dogs must be left outside in a kennel crate or other means.

Cleaning: Please be sure to sweep and wipe down countertops, floors, and fridge. Be sure all dishes and cooking equipment have been cleaned. Owner will launder linens upon return. At the sole discretion of the owner, if trailer is returned excessively dirty, a minimum \$200 penalty fee will be charged.

Lost and found: Owner is not responsible for lost or misplaced items, or those left behind by Renter. Renter should notify Owner immediately if Renter discovers he/she left any item in the trailer, and Owner will notify Renter if the item is found. Renter shall be responsible to arrange the shipping and pay the shipping costs for return of the found item.

Any damage must be reported to Dorian & Amy Funk immediately. This allows us to make arrangements for repair and notify the next renter of possible delay. Repairs must not be performed by renter unless authorized by Dorian & Amy Funk.

Failure to abide by these terms or intentional misrepresentation of travel plans shall, at the option of Owner, cause early termination of the Rent Term and Renter's use of the trailer and forfeiture of all rents and deposits.
