- **3. RENTALINSURANCE:** RV Share provides insurance and is paid through the website. A copy of the insurance card is provided and must be kept in the RV at all time.
- **4. CLEANING:** Each property will be inspected, sanitized and cleaned after your departure. We ask that the **w** returned in the same general condition that you received it. If a significant cleaning is required, appropriate charges will be deducted from your deposit at the rate of \$35 per hour. Please be sure to empty the holding tank **w** before the unit is brought back. If Renter would rather not empty, the RV owner will empty for the Renter at an additional \$35 charge.
- 5. NO SMOKING IS ALLOWED: Since many people have allergies and it is difficult to mouthe odors and allergens associated with both pets and smoke, we must STRICTLY ENFORCE this policy.

  If evidence of smoking inside the Rental is found, any damage caused by smoking materials will be charged to renters damage deposit or credit card on file.
