# MILEAGE AGREEMENT

For the Rental of Forest River Sunseeker Mercedes Benz Motorhome Year: 2019 VIN: 8BNPF4CC9JE151238 Plate Number: VNW4342

This Mileage Agreement is a supplement to the **Rental Agreement** for the Forest River Sunseeker Mercedes Benz motorhome ("Vehicle") provided by Mike Ab. By signing below, the renter(s) ("Renter") agrees to the following terms regarding mileage use during the rental period.

# 1. Unlimited Mileage Policy

The **Renter** is granted **unlimited mileage** for the duration of the rental period as long as the trip remains reasonable for typical leisure travel. This includes unlimited mileage for the first **4 days** of the rental period.

## 2. Excessive Mileage Policy for Rentals 5 days or longer

For rentals of **5 days or more**, the Renter agrees to adhere to the following mileage guidelines:

- 200-250 miles/day (round trip) is considered reasonable use for typical leisure travel.
- Extra mileage charges may apply if the rental is deemed to involve excessive usage beyond reasonable expectations, which may include consistently exceeding 200-250 miles/day, or taking a trip that causes unusual wear and tear on the vehicle.

#### 3. Reasonable Use and Extra Mileage Charges

The **Renter** agrees to use the motorhome responsibly and acknowledges that excessive mileage will be determined on a **case-by-case basis**. Mileage charges will be assessed for instances where the rental involves:

- Excessive daily mileage beyond typical leisure travel (e.g., long-distance travel).
- Any usage that results in additional wear and tear on the vehicle, fuel consumption, or maintenance costs.

Extra mileage charges will be based on **reasonable use** and are <u>not strictly limited to</u> <u>exceeding 200-250 miles per day.</u>

#### 4. Mileage Charges

- Extra mileage charges will be assessed at \$0.35 per mile for excess miles driven, but charges may vary depending on the nature of the usage and the duration of the rental. The final amount will be determined based on the overall **reasonable use** of the vehicle.
- Any extra mileage charges will be **deducted from the Renter's deposit** through the rental platform used (e.g., RVshare, Outdoorsy, RVez, or similar). These charges will be calculated and collected **after the return of the Vehicle**, based on the mileage reported.
- The **Renter** authorizes the host or rental platform to deduct any applicable charges from their deposit upon return of the vehicle, and the Renter agrees to pay any balance if the deposit is insufficient to cover these charges.

## 5. Authorization to Charge Without Dispute

By signing below, the **Renter** acknowledges and agrees that:

- The **Renter** grants the **Host** permission to charge for any excess mileage, as outlined above, without dispute.
- The **Renter** understands that any extra mileage charges will be deducted from their deposit through the rental platform used (e.g., RVshare, Outdoorsy, etc.).
- The **Renter** agrees to these terms and acknowledges that failure to adhere to the mileage limits may result in additional charges, which will be processed without the possibility of dispute.

## 6. Agreement to Terms

By signing below, the **Renter** acknowledges that they have read, understood, and agree to the terms outlined in this **Mileage Agreement**, and they understand that extra mileage charges may apply based on **reasonable use**. The **Renter** agrees to follow the outlined mileage policies during the rental period and authorizes the rental platform to collect additional mileage charges from their deposit if necessary.
